**Suit Brought Against Toshiba Subsidiaries in Europe**

TOKYO— Toshiba Corporation today announced that a claim (complaint) has been served on a consolidated subsidiary based in Germany, Toshiba Electronics Europe GmbH (TEE).

1. Date of the action

Date of service upon TEE: August 22, 2017 (Germany time)

2. Outline of the litigation and history

The claimants (plaintiffs) seek compensation in the English High Court from TEE, Toshiba Information Systems (UK) Ltd (TIU) and Toshiba Europe GmbH (TEG), jointly and severally, for losses they argue they suffered as a result of a cartel in the CRT business in certain EU countries, in which Matsushita Toshiba Picture Display (MTPD), an affiliated company of Toshiba until 2007\*, was found to be involved.

4. Damages sought

The amount of the Claim (compensation) sought by the claimants is unspecified and subject to the Court's assessment, should the case proceed. The claimants seek damages from TEE, TIU, TEG and, a fourth defendant outside Toshiba Group, in respect of the period 1 April 2003 to 12 June 2006, and purport to estimate their losses for this period at 91.43 million euro (approx. 11.8 billion yen).
